CLIENT INFORMATION

This contract is an agreement between *The Purrfect Pet Buddies Co.* _____ (client) for pet care services beginning on _____ and thereafter on an as-needed basis.

PET CARE AND PAYMENT

1. Pet care services will be provided at the following rate: \$_____ for daily walk-in and \$_____ for overnight stay. Rates for subsequent services are subject to change.
2. Client authorizes *The Purrfect Pet Buddies Co.* to perform pet care services as outlined in Client's Service Agreement and Veterinary Release, which shall become part of this contract. Prior to any future pet care services client agrees to notify *The Purrfect Pet Buddies Co.* of any changes to the information on these forms.
3. **Emergency Care:** In the event that pet(s) being care for requires immediate medical attention, *The Purrfect Pet Buddies Co.* will attempt to contact the Client prior to obtaining emergency care. However, Client agrees that pet sitter has the authority to act in pet's best interest even if this means seeking medical attention prior to notifying Client. Client agrees to reimburse *The Purrfect Pet Buddies Co.* for any additional fees and/or expenses incurred while tending to emergency or veterinary care.
4. **Inclement weather/natural disaster/Act of War:** In the event of inclement weather, natural disaster, or act of war *The Purrfect Pet Buddies Co.* is entrusted to use best judgment in caring for pet(s) and home. Client recognizes that in the event of inclement weather, natural disaster, or act of war *The Purrfect Pet Buddies Co.* reserves the right to alter services outline in this contract.
5. **Personal Emergency:** In the event of personal emergency or illness of pet sitter, Client authorizes *The Purrfect Pet Buddies Co.* to arrange for another qualified person to fulfill agreed upon responsibilities as set forth on this contract. Client will be notified in such case.
6. **Key Return Policy:** Client may agree to allow *The Purrfect Pet Buddies Co.* to keep their keys on file in a secure location for future services. If client prefers to have key returned, Client agrees to pay \$10 pick-up fee for future services.
7. **Locksmith:** Client gives *The Purrfect Pet Buddies Co.* the authority to use the services of a locksmith in the event of malfunction of the lock, keys, or automatic door opener. Client also agrees to reimburse *The Purrfect Pet Buddies Co.* within 7 days of consequences related to the activities of the locksmith.
8. **Payment:** Client agrees to make payments in full prior to first visit.
9. **Extra Service:** Any changes for unplanned services will be due within 7 days of completion of service engagement. Invoice for additional charge (including drop-off of keys) will be left at Client's home upon completion of service engagement (**Initial** _____).
10. **Confirmation:** Client agrees to call *The Purrfect Pet Buddies Co.* office prior to leaving to confirm departure day/time, and again upon returning home to let us know that pets are safe. If Client expects to arrive home earlier or later than planned, *The Purrfect Pet Buddies Co.* must be notified as soon as possible.
11. **Cancellation:** *The Purrfect Pet Buddies Co.* requires a 24-hour notice of cancellation. Less than 24 hours notice will result in Client being charged for 50% of the fee for booked services.

LIABILITY

1. *The Purrfect Pet Buddies Co.*, its employees and/or independent contractors, agrees to provide he services in a caring, responsible manner. The Client waives and relinquishes any and all claims against *The Purrfect Pet Buddies Co.*, its employees and/or independent contractors, except those arising from negligence of the pet sitter. Client agrees to notify *The Purrfect Pet Buddies Co.* of any concerns related to agree upon services within 24 hours of return home.
2. **Emergency Contact:** Client agrees to provide *The Purrfect Pet Buddies Co.* with contact information where he/she can be reached while away. Client will also provide a name and phone number of someone who is authorized to handle any major problems that may arise. If Client or designated contact person cannot be reached

in a timely manner, Client agrees to accept any decision *The Purrfect Pet Buddies Co.* makes in regards to pet care or Client's property.

3. **Visitors:** If anyone will be entering Client's home while it is under our care, Client agrees to notify *The Purrfect Pet Buddies Co.* in advance. *The Purrfect Pet Buddies Co.* will not enter an occupied home if we have not previously made us aware of visitors. Similarly, unless we receive instructions from Client, we will not grant access to the home to any visitors. *The Purrfect Pet Buddies Co.* will not be held responsible for any damages incurred to Client's home or pet(s) by visitors. It is understood that anyone with access to the home will be notified of *The Purrfect Pet Buddies Co.* presence and vice versa. The police will be called, without exception, on all intruders or suspicious acts.
4. **Outdoor Access:** *The Purrfect Pet Buddies Co.* will not be held liable for the well being or actions of any pet with unsupervised access to the outdoors.
5. **Aggressive Pets:** If a pet has a history of biting or other aggressive behavior, *The Purrfect Pet Buddies Co.* reserves the right to refuse or cancel service. The owner will be liable for the pet sitter's medical expenses and/or damages that are the result of an animal bite or injury due to pet's aggressive behavior.
6. **Vaccinations:** Client agrees to provide *The Purrfect Pet Buddies Co.* with proof of current vaccinations for all pets. Should pet sitter be bitten or otherwise exposed to any disease or ailment received from Client's animal(s), client agrees to pay all costs and damages incurred.
7. **Future Services:** Client authorizes this signed contract to be valid for future services without additional signed contracts or written authorization.
